Brand New SIRS Report and PK Students:

- The Brand New SIRS Report generates a list of eligible students in grades P4-12th grade students that were present and identified in NYS sorted by school district
- In order for P4-P5 students to be displayed in this report, one of the following options needs to be flagged on the Student Side/ School History tab:
 - ◆ Preschool SpecEd
 - ◆ PreK
 - ◆ District PreSchool
- **NOTE:** This report is quite complicated since it does not follow our regular enrollments dates but school enrollment dates (07/01/1*-06/30/1*). If you believe that you are missing a student on the report, give us a call.

End of Term MSIX Minimum Data Elements:

In order to be in compliance with the new MSIX regulations, DSs should try to do their best in collecting/entering the following information by July 22, 2016:

- All students eligible during 2015-16 Academic Period must have:
 - * Enrollment Date, Enrollment Type, Withdrawal Date, Facility Name
- For Pre-School Students review/update:
 - * IEP Indicator (if applicable)
 - * LEP Indicator
- For K-8 Students review/update:
 - * IEP Indicator
 - * LEP Indicator
 - * PFS Flag (review all other Needs related to this field)
 - * District of Residency
 - * Home School Indicator
- For HS Students (possibly some 8th graders) review/update:
 - * All Data Elements listed above for K-8 students
 - * All required fields for Assessment Information (review May'16 Newsletter)
 - * All required fields for Credit Accrual Information (review April'16 Newsletter)
 - * NOTE: As of June 9, 2016, we will try to collect/enter transcript information for all HS students. Work with your tutors in order to make the collection of transcript as part of the initial/end of term process for HS students



Education Interrupted:

- ⇒ This is a very important data field since it is the first condition that needs to be met in order to flag a student as PFS.
- ⇒ Here is the definition according to our manual:

Student who in the preceding 12 months changed school buildings or missed significant amount of school time (10 days or more) during the regular school year (usually defined as September through June) due to the student's family's lifestyle.
- ⇒ DSs please help METS Director and tutors in reviewing this information on the Student Summary Forms
- ⇒ TIP: Run a report for tutors showing the Residency Date for In School students using 09/01/1* as the reference point.
