- Field trips and fun activities such as roller skating, kayaking and picnic at the lake, etc.




#### What can your students expect?




- 8 Counselors- 7 of them are CAMP students from SUNY Oneonta

## **Student Recruitment**

- April and May- prime time to recruit. Start talking to your students ASAP!
- Applications are due June 4<sup>th</sup>- Jenny will cover where to access forms, and what you, your student, and your student's parent/guardian need to do.
- Don't limit yourself- we will accept up to 30 applications. If you have a student, submit the application!
- Please prioritize students that have not attended SOMLA before!

#### **Recruitment "Elevator Pitch" Suggestions**

- This is a scholarship and you have been selected. Opportunities like this do not come every day!
- The program is completely free and safe to attend.
- 1 College Credit
- Real college experience (opportunity to try it out and see if it's for you!)
- May open the door for future career opportunities letters of recommendation, connect with professionals, etc.
- Your future self will thank you for investing in yourself for these 6 days.

## Who is a Candidate to Attend SOMLA?

- Current migrant eligible students or Continuation of Service students.
- Rising 11th-12th graders. Invite your 10<sup>th</sup> and 11<sup>th</sup> graders.
- Responsible and self-motivated.
- If 10<sup>th</sup> grade student- good academic standing
- Available to commit to the schedule- 6 days at SUNY Oneonta.
- This program may be challenging for very beginner English Language Learners (ELLs), but we will support all students and their needs.



# How will we be supporting individual learning needs?

- Interpretation/translation will be provided.
- If your student has an IEP or any specific learning need(s) listed on their application, we will do everything we can to provide individualized support to that student. Providing a copy of the IEP will help us create the best possible support plan for your student!

#### Paperwork Reminders:

- Check the name of the students- official names required.
- All forms should have consistent data (example: current address.)



#### **Official Transcripts**

- 1. Give the Transcript letter to the guidance counselor along with the SOMLA flier. Ask them if they have any questions and when you can expect they will be able to upload the transcript.
- If you do this in person, please also let the guidance counselor know that you will send the letter via email and copy Jenny and Odilia for follow-up purposes
- 3. Jenny will do a follow-up email with the school counselor
- 4. We will ask the guidance counselors to upload the transcript between the last day of school and July 3, 2025

#### **Official Transcripts**

5. We will ask school counselors to upload the transcript via Citrix to Jenny or Odilia by July 3<sup>rd</sup>, 2025 <u>https://nysmep.sharefile.com/share/upload/r56550a2334264ff8b</u> <u>ab568af6cb6e04c</u> \*Need to verify if student completed 10<sup>th</sup> grade

#### Transcript Letter

Dear School Counselor,

Your student has been nominated to participate in the <u>2025 SUNY Oneonta Migrant Leadership</u> <u>Academy (SOMLA)</u> this summer. Please see the enclosed flier for more information about the program. One college credit for *Transition Skills for Emerging Leaders (INTD 1220)* will be granted to students who successfully complete SOMLA. SUNY Oneonta requires an **official** high school transcript to enroll students and grant credit for INTD 1220 upon successful completion. The official transcript must be signed by a school official, show the student's final school year grades, and show that the student has successfully completed their sophomore year.

We have established a system for you to securely upload your student's transcripts. Please upload the official transcript file to the <u>NYS Migrant Education Program's secure file-sharing</u> <u>service via Citrix.</u> To do so, click the hyperlink, and you will simply be required to enter your name and email address before moving the file to our designated folder. Should you need assistance with this process or for an alternative, please reach out to Jennifer Verdugo via email <u>Jennifer.Verdugo@oneonta.edu</u> or call 585-739-2821. Once a transcript is received, Jennifer will follow up with you to confirm its receipt and request any additional documentation.

Please be advised that transcripts must come directly from the student's high school, prior to the arrival of students at SUNY Oneonta. The transcripts **must be signed by a school official** to be considered official. We kindly request that you **upload the transcript no later than July 3**, **2025**, to avoid any holiday delays.

#### New Form – Prescription and Over-the Counter Medication

#### Prescription and Over-the-Counter Medication Consent Form 2025 SUNY Oneonta Migrant Leadership Academy (SOMLA)

If your child needs *any* kind of medication while at SOMLA, we need your consent for medication distribution *and* for the use of medical devices.

For prescription medications, we need additional information from the prescribing physician as well. See below.

### Working Together to Get Students to SOMLA

#### METS Staff

- Identify student candidates.
- Introduce program to students.
- Help students complete application process.
- Communicate student needs to Emily/Odilia.
- Keep students in the loop about new information or updates.
- Help students understand what to pack.
- Facilitate transcript requests.
- Coordinate transportation plan.

#### ID&R

- Respond to student/parent or staff questions about SOMLA.
- Communicate new information or updates to Directors/METS staff.
- Communicate about student paperwork needs/concerns.
- Follow up on transcript requests.
- Call applicants and parents (separately) to introduce program and answer questions.
- Make preparations for specific student needs.
