Educators and Directors use the Academic Service Intensity Rubric (ASIR) with the needs assessment data collected to determine the individual Service Level for each student in program year 2024-25.

BOLST - Assessment Form & Score Sheet

Educators use this tool to administer the Basic Oral Language Screening Tool (BOLST) in person and record student responses. The BOLST can be used virtually or in person for program year 2024-25.

BOLST - Listening & Pictures PowerPoint

Educators can use these PowerPoint graphics and recorded questions to support the administration of the BOLST in person or virtually for program year 2024-25.

BOLST - Pictures Only

Educators can use these pictures from the BOLST PowerPoint, in person, to support the administration of the BOLST in program year 2024-25.

easyCBM Optional Support Tool (1) – Quick Phonics Screener

If your student scores less than the 40th percentile on the easyCBM ELA Passage Reading Fluency (PF), the Quick Phonics Screener (QPS) can help you identify areas to focus on. Go to the ELA Resource Library for related instructional resources.

easyCBM Optional Support Tool (2) – Logic Model

Use after administering the QPS to help you determine next steps and resources for student instruction.

ECA Guidance Document

Educators use the Guidance Document to prepare props, administer, and score the ECA in program year 2024-25.

ECA Student Response Sheet, English

Now with a “fillable” option, Educators can use the Student Response Sheet to record student responses for the ECA in program year 2024-25.

OSY Profile

Educators use OSY Profile to collect additional needs assessment data for OSY students for program year 2024-25. Options: Educators can enter the responses in Web App, and METS can print individual copies from MIS2000.

Personal Learning Plan

Educators use the Personal Learning Plan (PLP) to set and track short-term educational goals with Level 2 Out-of-School Youth. Options: Educators can enter the information in Web App or use this form to write/type the information.

School Year - Mid-Year and Student Summary Form

Educators use the Mid-Year form to update needs assessment information as needed throughout the 2024-25 program year. METS programs generally run personalized copies from MIS2000 with basic information from the COE prefilled for each student.

School Year - Mid-Year and Student Summary Form Guidance Document

This guidance document explains each data element collected in the Mid-Year and Student Summary Form for Program Year 2024-25.

School Year - Student Intake Form

Educators use the Student Intake Form (SIF) to collect initial needs assessment data for the 2024-25 program year, and again, when students arrive in a new district. METS often print the SIF from MIS2000, prefiling existing data for each student.
